

# Academic Regulations: Interruption of Studies, Transfer, and Withdrawal

## 1. Introduction

- 1.1. Studying for an award at any level requires dedication, compromise, and hard work. Many of you will be studying alongside other things going on in your life and we understand that many of you will, at some point in your studies, question whether you have chosen the right course or the right time in your life to study. Sometimes, taking time away from your studies can help you decide these queries, and can allow you time to address some of the things you have going on that are impacting on your ability to study. This section of the Academic Regulations explains the options available to you, as well as the circumstances in which we might put you on an interruption.
- 1.2. This section of the Regulations applies to all courses unless otherwise indicated in the relevant Course Specification.
- 1.3. The applicability of these Regulations under the University's Collaborative Provision arrangements is detailed in Schedule A.

## 2. Interruption of Studies

- 2.1. An Interruption of Studies is an extended period away from active studies. This means you are pausing your studies from a specific point in your academic term and will return within a maximum of one year to resume your studies at the beginning of the term (and/or module) in which your interruption began. Only one Interruption of Studies may be granted throughout your studies on your course. This means that if you take an Interruption of Studies and then transfer to another course at the same level you cannot request another Interruption of Studies. However, if you take an Interruption of Studies during your undergraduate studies, and then study with us again at postgraduate level, you may request an Interruption of Studies for your postgraduate course. Exceptionally, and where the reason for the request for an Interruption of Studies demands, we can grant an Interruption of Studies for up to 18 months.
- 2.2. An Interruption of Studies is usually taken where:
  - a. There has been a change in your circumstances that you could not predict, and which you could not have prevented.
  - b. You need to be absent from the University longer than allowed by any other process.
  - c. A return date and completion of any conditions of return are possible within usually no more than one year following the first date of the interruption.
- 2.3. We can impose an Interruption of Studies on you with good reason and in the following circumstances:
  - a. Your attendance and/or engagement falls below 75% across any single term, academic year, or the duration of your award. Such decisions are made by a Panel taking into account official attendance data, information from your module leaders and/or course leader, and any information you submit to be taken into consideration by the Panel.
  - b. You are unable to begin a compulsory placement on a core module by the deadline set.
  - c. You are unable to begin a period of Study Abroad.
  - d. You are due to return from an Interruption of Studies but have no active modules in the next available term.
  - e. As a result of a penalty set by a Misconduct Panel.
  - f. You are found to be temporarily unfit for study.

- 2.4. If you are thinking about Interrupting your Studies, you must consider the following factors:a. You remain an enrolled student while on an Interruption, and the following applies:
  - i. You are not able to access support services such as Student Experience and Welfare, careers, or the library; and you are not allowed to remain in university accommodation. This is because we prioritise active students' need for these services.
  - ii. You must continue to meet our expectations regarding good conduct. This means that if you do something while on a study break that would be referred through the misconduct regulations, we may still refer you, even though you are not an active student.
  - b. You cannot take an Interruption of Studies after you have been notified that:
    - i. A misconduct allegation has been made about you and before the matter has been completed.
    - ii. We have referred you for fitness to study and before the matter has been completed.
    - iii. We have Interrupted your Studies already or withdrawn you for any reason.
  - c. You will not be awarded academic credit for modules partly completed at the point your Interruption began.
  - d. Assessment Boards are held at the end of each term. This means that at the point your Interruption of Studies began:
    - i. You will receive the marks for any assessments submitted if they have been presented and approved by the relevant Assessment Board.
    - ii. Any assessments submitted in the term your interruption began that have not been considered and approved by an Assessment Board are lost. You will have to complete the assessment(s) again when you return to your studies.
  - e. When you return from an Interruption of Studies you will have the same number of remaining assessment attempts as you had at the point your Interruption of Studies began.
  - f. When you resume your studies, we will not extend your maximum period of registration to include the duration of your Interruption of Studies. If we grant your Interruption of Studies, we will tell you when your expected course end date is.
  - g. We may not be able to allow you to return to a course or module that has been discontinued or significantly changed during your Interruption of Studies. Although we will try to find a suitable replacement, if we are unable to do so we may request that you withdraw.
  - h. You are not entitled to request a refund for the proportion of the academic year and/or term from the point after your Interruption of Studies began. Up to teaching week three of the term applicable to your course, the fees paid for the academic term or year will carry forward when you resume your studies. From the beginning of teaching week four applicable to your course up to the end of that term, the fees paid for the academic term or year will not be carried forward when you resume your studies and you will have to pay again for that term when you resume your studies. However, any partial fees for the remainder of the academic year in which you resume your studies will be due at the fee level in operation when you resume your studies (not the level in operation when your Interruption of Studies began).
  - i. Although we do not share the reason, we inform the following areas about all students taking an Interruption of Studies, including the start and end dates:
    - i. Your Course Leader and relevant Director (Content).
    - ii. Student Immigration and Compliance (if a visa-holding student). This will mean that we notify UKVI of your inactive status and you will be required to leave the UK.
    - iii. Student Experience and Welfare.
    - iv. Library.
    - v. Careers.

- vi. Finance.
- vii. Accommodation.
- viii. Security.
- 2.5. Before submitting a request to Interrupt, you must speak to your Course Leader and a member of the Student Experience and Welfare team. You may also need to speak to a member of our Student Finance team to understand any implications regarding fees and other payments (such as accommodation). If you require a visa to study with us, you must speak to the Student Immigration & Compliance team. This is because we are obliged to inform the UK Home Office of any Interruption of Studies meaning you would be required to leave the UK immediately.
- 2.6. To request an Interruption of Studies you must submit an online application. Your application is considered by staff in the Registry team on a confidential basis. This means that we will not share your application or the reasons for your request to Interrupt your Studies unless there is a good or compelling reason to do so. However, we may seek input from relevant teams for example Student Immigration & Compliance, Finance and Director (Content), or nominated representative. The decision on your application for an Interruption of Studies will normally be made and confirmed to you within five working days. You must continue to engage with your studies and meet any attendance requirements while your application for an Interruption of Studies is being considered.
- 2.7. Where your Interruption of Studies is approved, we will confirm your expected return date and any conditions you must meet before being allowed to return. At least one month before your return date we will invite you to meet with a member of the Student Experience and Welfare team. The meeting is to review any conditions of your return and agree academic and/or personal support as relevant. If you have not met all the conditions of return, we may decide to extend your period of Interruption, or withdraw from your studies.

## 3. Transfer

- 3.1. If you think you may not be on the right course for you, you may be able to transfer. A transfer is a way for you to ask to move to another course that we deliver. You may not transfer to any other course you will need to demonstrate you meet the entry requirements of the course you want to transfer on to.
- 3.2. Transfer applications must be made by the end of the third week of teaching at the beginning of your academic year. This means that if successful you would transfer to the new course by the end of teaching week 4 of the beginning of your academic year. Applications are made using the online form. The application will take into consideration any course specific requirements and will be reviewed by the Registry team in conjunction with the relevant Director(s) (Content), or nominated representative, and the outcome will confirm whether any credits achieved can be used as part of recognition of prior learning (RPL) or not. The Student Immigration & Compliance team will review the application and confirm if the request fulfils and meets the visa requirements. You will normally be informed of your transfer decision within five working days of form submission.

## 4. Withdrawal

- 4.1. If you decide that you no longer want to continue your studies, you can request to withdraw. This means that, once agreed, you will leave the University immediately and will no longer be an enrolled student. Any request to return to your studies at a later date will be considered under the Admissions policy and is not guaranteed.
- 4.2. We recommend you speak to your personal tutor, the Student Finance Team, and the Student Experience and Welfare team, before requesting to withdraw from the University. If you hold Student visa sponsorship, you should speak to the Student Immigration team before withdrawing. We are obliged to notify UK Visas & Immigration of your withdrawal

which will result in the cancellation of your visa. To withdraw from the University, you must complete an online form. It is not possible to consider retrospective or backdated withdrawals.

- 4.3. As part of the process of considering withdrawal requests, you will be required to meet with your Course Leader and a member of the Student Experience and Welfare team.
- 4.4. Your academic profile and marks will be considered at the next available assessment board who will determine if you are eligible to receive any interim/exit award.
- 4.5. Once withdrawn, you may be eligible to apply to return to the same course of study within one year from the date of your withdrawal, subject to the Readmission Regulations in operation at the point you apply for readmission. If you wish to apply to a different course, you will need to make a fresh application through the normal admissions process
- 4.6. There are other circumstances in which we may decide to withdraw you from the University. These include as a result of poor attendance per the Attendance Policy, because of academic or behavioural Misconduct, or Academic Failure.

## 5. Schedule A

The applicability of these Regulations (as set out above) under the University's Collaborative Provision arrangements is detailed below.

Where the Regent's University London Regulations apply, collaborative partners may use different terminology, e.g. 'programmes' and 'units' instead of 'courses' and 'modules'.

#### **DOMUS Academy**

- 5.1. Regent's University London's regulations apply, with the following variations:
  - a. Interruption of Studies will normally be for a maximum period of 6 months.
  - b. Transfer To be submitted within 7 working days of the course beginning.

#### Istituto Marangoni (London)

5.2. This section of the Academic Regulations is replaced by Istituto Marangoni's Suspension of Studies, Programme or Pathway Change, and Withdrawal policy.

#### Istituto Marangoni (Paris)

5.3. This section of the Academic Regulations is replaced by Istituto Marangoni's Suspension of Studies, Programme or Pathway Change, and Withdrawal Policy.

#### Liverpool Media Academy (LMA)

5.4. This section of the Academic Regulations is not applicable to students studying at LMA. Students should refer to LMA's Intermittence, Transfer and Withdrawal Policy.

## MACROMEDIA

- 5.5. Regent's University London's regulations apply, with the following variations:
  - a. Interruption of Studies no later than 8 weeks before the end of term.
  - b. Transfer To be submitted by 1 February or 15 August.
